Global Shea Alliance Organizes National Shea Conference and Opens New Annex Office in Togo

ACCRA, GHANA, November, 23, 2021—The Global Shea Alliance (GSA) in partnership with Shea Interprofession of Togo, Conseil Interprofessionnel de la Filière Karité du Togo and Enhanced Integrated Framework (EIF) is hosting the first ever two-day National Shea Conference on November 30th and December 1st, 2021. The event themed "**Connecting the shea industry in Togo to the global industry**" will be officially launched along-side the GSA's office annex on November 29th, 2021 by Her Excellency, Victoire Tomegah Dogbe, the Prime Minister of Togo.

The launch of the office annex is tied to the GSA's 5-year (2020-25) strategic plan which seeks to improve business skills of women collectors, restore degraded parklands, boost local-value addition in the region, harmonize policies to improve intra-Africa and international trade and secure contributions to support industry sustainability initiatives. Additionally, the office annex will help the GSA deliver the much-needed technical support to current and prospective members in Togo and neighboring countries like Benin, Burkina Faso, Mali, help strengthen our partnership and relationship with governments, donor organizations and other key stakeholders as well as support national associations in the region.

"I am elated at the many opportunities that opening this office will bring. It connotes the progress and expansion of the GSA as an industry association and brings into focus shea as a growing international commodity." said Simballa Sylla President at GSA. "The team has done good work so far connecting stakeholders across Africa and globally. We hope opening a center curated to our francophone members will further boost investments and advance shea processing in the region".

The National Shea Conference hosted as part of the PRADCIFK initiative will draw in industry players and experts across the region. The conference agenda will address current challenges facing the Togolese shea industry, opportunities to improve processing and exports, accessing new investments as well as job creations through shea. The conference will feature technical trainings on export requirements for Asian and African markets, exhibitions, and a field visit to one of the largest shea processors in Togo.

"To sustain industry-wide growth, conferences like these are very important and need to happen progressively.
